- The above fees will apply in the event that your Chiropractic care is not covered by a third party who we can bill directly, for example:
 - WCB in the event of a work injury or
 - SGI in the event of a motor vehicle accident or
 - Saskatchewan Health if you qualify under Social Services, Supplemental Health Insurance, Seniors Income Plan, or Family Income Plan or
 - Blue Cross if you are an RCMP member or Department of Veterans Affairs member
- If you have experienced a work injury or motor vehicle accident, be assured that we will do everything possible to help you with your claim by filling out the appropriate paperwork, etc. However, please understand that the acceptance of your claim rests exclusively with WCB or SGI. If they accept your claim, we will bill them directly. If not, you will be financially responsible for your care.
- If you qualify for Chiropractic care under Social Services, Supplemental Health Insurance, Seniors Income Plan, or Family Income Plan, please understand that Saskatchewan Health will cover the fee for the first twelve (12) visits only beginning April 1 of every year.
- Many insurance companies and group health plans offer benefits that assist with, or cover the cost of, Chiropractic. It is your responsibility to check your policy to verify your coverage. In order for us to keep our fees reasonable, we ask that you pay for your care and submit your receipts directly to your insurance company for reimbursement.
- Receipts will be issued in the name of the person who is receiving the chiropractic visit.
- Payment in the form of cash or debit/credit card is due when service is provided.
- We schedule appointments at a time specifically for you. We will do everything we can to be on schedule and therefore respect your time. Likewise, we ask that you respect our time by arriving on time for your appointments. If you believe you may be late, we ask that you contact us by phone so we can rearrange your appointment for you. Please try to arrive 5 minutes prior to your scheduled time.
- **We require 4 hours notice to change or cancel your appointment time, and 24 hours notice is appreciated. The full fee of your booked appointment may be charged if you are unable to provide adequate time (4 hours) to fill the timeslot. You may be unable to book further appointments at Wholelife Wellness until this invoice is paid. Insurance companies will not reimburse missed appointment fee receipts. This will be enforced, if necessary, at the beginning of your care.**
- As a professional courtesy to others in the centre, we ask that you please turn your cell phone off or to silent mode.
